## FEES STRUCTURE

Since AAOIFI is a **not-for-profit making organization**, the fee structure is designed to accommodate and allow participation from a broader base of industry practitioners. The fee structure allows the candidate to choose from the following two options:

- Option 1: US\$2,700  
Registration fees + Study Materials + Training fees + Examination fees
- Option 2: US\$1,900  
Registration fees + Study Materials + Examination fee

### **Cancellations, Substitutions & Withdrawal:**

- Refund will be given to cancellation or withdrawal cases only for amounts related to program fees, and training fees ( if a candidate has not attended the training), and examinations fees. A withdrawal charge of US\$250 will be imposed on all cases.
- Substitutions are may be allowed at any time up until the date of training (for Option 1) or examination (or Options 2).

### **Training:**

- Training classes will be carried out in Arabic and English and held in Bahrain. If training classes are also held in other locations, candidates will be informed after the locations have been confirmed.
- Training classes will be organized if there is sufficient number of registered attendees.
- Training fees will be refunded if the training classes are not held.
- Deadline for registration for the training is three weeks before the training date
